

Agree to Equipment Assignment Terms

In order to receive equipment furnished by Blackfoot School District, you must read and accept the terms below. Once you have read the terms below, you may signify your acceptance by signing on the line labeled 'I Accept.'

I, _____, realize that any technology equipment assigned to me is owned by Blackfoot School District. I may not have equipment assigned to me unless I accept this agreement. I also understand the following restrictions apply to my use of any technology equipment assigned to me:

- I have read, understand and agree that the Blackfoot School District Acceptable Use Policy applies to my use of this technology equipment, whether at school or off school grounds.
- I am aware of the optional BAPE program explained on the other side of this paper.
- I am directly responsible for any content placed on technology equipment assigned to me. Current laws regard inappropriate content as a criminal offense (Idaho Code Section 18-1514). Any equipment assigned to me is subject to search at any time by approved district personnel.
- I will not load any software, music, videos, etc...for which I do not own the license.
- It is my responsibility to have the district-owned virus protection software loaded on my assigned equipment at all times.
- It is my obligation to keep my assigned equipment and data secure and protected at all times. I am responsible to back up my data.
- I understand that if I damage my assigned equipment, my school will be asked to pay all repair costs. Some or all of those costs could be assigned to me.
- I understand that the District Technology Technicians will not help me at home.
- I will not delete any administrative user accounts from my computer.
- I understand the following protocol applies to equipment loss or theft or other causes:
 - ** Lost or stolen equipment must be reported to my School Administrator, Police (in case of theft), and District Technology Department.
 - ** The district will cover theft in case of obvious break-in at the school. District insurance may not be extended to off campus claims. If assigned equipment is lost/damaged while in my control with no evidence of break-in or damage incurred by someone else, I will be liable for the cost of the repair or replacement.

Blackfoot Assurance Program for eDevices (BAPE)

What is it?

The iPad Damage Optional Insurance program is designed to help offset the costs of a lost or damaged iPad to families. School Board policy (Blackfoot Board Policy 548) requires restitution be assessed for lost or damaged school property including Technology. However, unlike the loss of a sports uniform or damage of a textbook, the costs for an iPad can be greater. Optional insurance is our way of helping offset unforeseen expenses for families. This program is optional, but can provide significant savings in the event of accidental damage or loss.

How much does it cost?

The iPad Damage Insurance Policy premium is an optional, annual, non-refundable \$25/year premium per participant. It is not proratable for partial semesters. Students who newly enroll in the district during the second semester will have the option to participate in that school year's coverage at the rate of \$15. The amount of the premium may change from year to year based on data from the previous year's damage rates.

To join the current year's insurance pool, any previous LTP partial insurance payments and repair fees must be paid in full.

New MacBook (if no repair is possible)	\$978

How do we opt in?

The Blackfoot School District will offer you the opportunity to participate in optional insurance coverage by assigning an optional insurance fee in Infinite Campus. To opt in, make payment before the enrollment window closes September 17, 2020. To opt out, simply disregard the fee - it will be voided at the end of the enrollment window for those who choose not to participate.

If you choose to not participate in this program, you will be responsible for the full cost of replacement or repair as outlined in Board Policy 548.
